Provide ACGME Input on Common Program Requirements Section VI

The ACGME's Phase 1 Task Force has completed its work on Common Program Requirements Section VI. The proposed requirements, along with an impact statement, are now available for review and comment. The Task Force will submit the final proposed requirements to the ACGME Board of Directors for approval, with implementation targeted for the 2017-2018 academic year. In summary, the proposed requirements:

- have an expanded section on patient safety and quality improvement;
- include a new section on physician well-being;
- strengthen expectations around team-based care; and,
- streamline resident clinical and educational work hours to be consistent across the country in a framework that is supported by educators.
