

Are You MACRA Ready?



The Medicare Access and CHIP Reauthorization Act (MACRA) was signed into law in April 2015. It created two new tracks for Medicare Part B payment: the Merit-based Incentive Payment System (MIPS) and Advanced Alternative Payment Models (AAPMs).

If you are an eligible clinician (MD, DO, NP, PA, CNS, CRNA) that participates in Medicare, in at least your second year of

nominations for membership on the CLER Evaluation Committee. Members will be selected based on current needs, professional qualifications, geographic distribution, and diversity in gender and race, and recommended to the ACGME Board of Directors for confirmation.

The CLER Evaluation Committee is currently seeking members from the following communities of healthcare professionals:

* Chief Executive Officers

* Chief Nursing Officers/VP Patient Services

* Chief Quality Officers/National Leaders in Quality Improvement

* Chief Patient Safety

Officers/National Leaders in Pt Safety * National Leaders in addressing

Health Care Disparities

* Public members (preference for advocates in patient safety and health care quality)

* National leaders in physician and/or resident wellbeing

* National leaders in interprofessional team-based care

* Physician leaders in a surgical/procedural/anesthesia specialty

* Resident or fellow physicians with significant training in patient safety and health care quality

All terms will begin July 1, 2018. The term for the resident member is 2 years (non-renewable). All of the other openings are 3-year terms with the option to renew.

2018 meeting dates for the new member(s) are as follows:

* July 9-11, 2018 - Chicago, IL * October 16-18, 2018 - Chicago, IL

Dates for 2019 and beyond have not yet been selected. Typically the Evaluation Committee meets four times each year in January, April, July, and October. Nominees will be notified of selection decisions in February 2018. Information about the CLER program and the ACGME may be found at <u>www.acgme.org/cler</u>. Medicare eligibility, MACRA applies to you and will either positively or negatively adjust your Medicare Part B payments. Faculty need to have knowledge of MACRA to educate their students and residents. Residents need to know MACRA to make informed decisions regarding moonlighting and employment.
